Dear Friend.

First, thank you for your interest in Vanderbilt and for communicating with us about your concerns. As General Counsel, I have been asked to respond to you.

Vanderbilt University has a nondiscrimination policy that prohibits discrimination within the University community. This is a long standing policy that is designed to protect members of our community and to provide a safe and nurturing campus atmosphere free of discrimination. All student organizations that wish to be registered at the University must agree to and actually comply with this policy.

All members of the University community are free to worship as they wish, however, all registered organizations **must agree to refrain from discrimination in its <u>membership</u>**. This prohibition exists for religious, as well as non-religious organizations.

As I hope you can see, Vanderbilt is not targeting any religious or non-religious groups, but is just trying to enforce its long standing nondiscrimination policy. In fact, the Dean of Students is working with a few organizations that have yet to comply to help them do so.

If you would like to discuss, I would be more than happy to talk with you about this matter.
